1. PRESIDENT'S REPORT 2021 - Sondra Anderson

We nearly made it through a full season without Covid restrictions but just prior to the July break we were shut down, so we all enjoyed an extended break. We had 2 weeks of mask wearing in the first weeks of the season but then it was pretty much back to normal. We were able to complete our 15 weeks of competition and reduced finals to Semi Finals 1 v 4 and 2 v 3 with the winners of these games paying in the Grand Final.

Courts 24 to 28 were resurfaced and the lights servicing these courts had their poles replaced by the City of Fremantle.

Light poles on courts 18-21 were also replaced after ceasing to turn on in mid-June – they were finally in working order in October with repairs being completed by the City of Fremantle.

We welcomed Jan Miles as Life Member at the AGM and accepted a new Constitution at our AGM.

On the technical side, we updated our website and embraced Office 365 allowing our staff to be able to work remotely if needed due to the ongoing Covid protocols.



We welcomed Brilliance Removalist & Storage as a GOLD sponsor which gave FNA the funds to install both the signage around the new kiosk and replace the aging wooden honour boards in the Pilatti Pavilion. The replacement boards are now magnetic, and we have also added additional honour boards for JA1 and SA1 premiership winners. Due to the amazing record keeping of past executive and the archive work completed by Lyn Lendrum we were able to create these records from 1960.

We said goodbye to Exec Member Sue McLennan-Atkins in March after 4 years of volunteer service and welcomed Amber Jones in June as Uniform and Equipment Coordinator.

Our FNA Holiday Clinic was held 5-6 July with 174 participants and 28 coaches (State, Sharks and FNA).

The Life Members morning tea was able to take place in 2021 and we finally opened the 2020 time capsule with Jude Pilatti joining us from Melbourne on Zoom due to lock downs.

High Street Redevelopment continued. Two court sweepers, which can be used in wet or dry conditions were donated by Georgiou Group to help us keep the fine dust under control. Our community took to them like a duck to water and there was never a shortege of helpers keeping our courts along

water and there was never a shortage of helpers keeping our courts clean - thank you.



A total of 476 teams registered in 2021 and starting game times changed, with the success of a 15 minute warm up on court it was decided to trial 7.45am start and 4.15pm start for the final game of the day. It was agreed that these times would continue in 2022.

We added an additional Barista Coffee machine to the kiosk which was very successful once the word got out.

The FNA Representative Team Program was held in June in hubs and FNA continued its success over the weekend with 17 teams representing FNA. 11 teams made finals and we came home with 7 wins. We also had an engagement proposal on Court 1 after the Open Team won the grand final, congratulations Tamaii Hallett – she said YES!

The following FNA members were announced in this year's WA 17U & 19U State teams including Bethan Duffill as umpire and were due to travel to Tasmania in July 2021, but the Nationals were cancelled due to Covid.

For the Set and Go presentations held on Saturday, 4th September we tried something new, a

photobooth, which was well received.

At the completion of the 2021 GIGWANL Season East Freo Sharks Netball Open team were knocked out of finals contention in the last game of the season and the 20U team finished minor premiers and finished runner up in the Grand final.

State Cup was played in the September school holidays with 5 FNA teams - 18U x 1 Team, 16U x 2 Teams and 14U x 2 Teams.

We held our eleventh annual Club Forum and set a new record finish time. It was very well attended meeting with robust discussion and exchange of ideas on all matters at FNA.

It was another successful Spring Netball season under lights with music. We continued Tuesday night Spring for those who didn't play Winter or wanted to play in a mixed team. What a success it was with 32 teams registered. A big thank you to Keryn Rae who ran the competition. Our traditional Wednesday night Spring completion was even more popular with 134 teams. Thanks to Jan Miles who coordinated Wednesday night but also helped out with Tuesday nights as well.

We trialled the new database PlayHQ for Spring which is set to replace MyNetball. We also commenced PlayHQ training with clubs in preparation for 2022 registrations.

We thank B1 Homes again at the completion of their \$75,000 sponsorship over 6 years with FNA. These funds were used to purchase uniforms for all FNA Rep Teams including tracksuits. Exec shirts and tracksuits were also funded through this very generous sponsorship.

We said goodbye and thank you for all your hard work to the Association - Dee Boni, Maxine Leed and Tania Plant and we thank them for their years of service at FNA. Nikaela Littmann Jones our administrator is moving to Melbourne so we say goodbye to Nik as well.

Metro League

We found as a playing group we could really refine the skill set of some of the players through the weekly training sessions as we could pull aside players and do some one-on-one work with the Assistant coach or ADO. This framework also highlighted some of the areas that need improving for a team, individual or an age group.

For the coaches it challenged them on working on the areas that needed attention. We were grateful to have Jaime-Leigh Strickland from East Freo Sharks give our 14U & 16U coaches mentoring and feedback which was well received. The ADO also supported and mentored all coaches on a weekly basis. Feedback has been given to NWA on the season. The timing of the season during the year was extremely hard on players, coaches, families, and grassroots clubs.

It was suggested this comp be played after the school holidays in Oct – Nov. Feedback was also given on the importance of the competition and how coaches, players and umpires all developed from the weekly competition and all games were hard fought games, so the competition was strong. There were also lots of WANL coaches viewing players in preparation for their trials.

1. STATEMENT OF ACCOUNTING POLICIES

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act (WA). The Committee has determined that the Association is not a reporting entity.

The financial report has been prepared in accordance with the requirements of the Associations Incorporations Act (WA) and the following Australian Accounting Standards:

The financial report has been prepared on an accruals basis and is based on historical costs and does not take into account changing money values, or except where specifically stated, current values of non-current assets.

The following specific accounting policies, which are consistent with previous period unless otherwise stated, have been adopted in the preparation of this financial report:

(a) Income Tax

The Association is an exempt body for income tax purposes.

Accordingly a provision for income tax is not required.

(b) Fixed Assets

The depreciable amount of all fixed assets are depreciated over the useful lives of the assets to the Association commencing from the time the asset is held ready for use. Leasehold improvements are amortised at rates considered appropriate by the Committee. The carrying amounts of all fixed assets are reviewed annually by the Committee.

(c) Grants

Grants received for asset improvement programs are accounted for based on a Capital Offset basis.

The grant funds are not considered as income rather offset against the asset capital costs in the balance sheet.
