## DEFINITIONS

**Admin:** The administrator of Sharks – [sharks@fremantlenetball.com.au](mailto:sharks@fremantlenetball.com.au)

**Affiliated Club:** An incorporated netball club affiliated and financial with FNA in the Winter Competition

**Contracted Athlete:** An individual who has been offered a position in a team for a specific season by Sharks and has accepted this position by completing the Athlete Participation Agreement

**Committee:** The FNA Pathways Subcommittee of the management committee of FNA

**FNA:** Fremantle Netball Association Inc

**FNA Futures:** The development program that encompasses all representative teams and other programs for FNA, including but not limited to Representative teams, Metro League, State Cup, the FNA umpiring Academy and any other program that the Committee determines to fall in the scope of the program.

**Representative Team:** A team of Athletes selected to participate in the FNA Representative Competition

**Sharks:** The teams entered into the WANL competition and WANL Futures program by FNA under the licence agreement with NWA

**NWA:** Netball WA Inc

**WANL:** WA Netball League, or the Gold Industry Group WA Netball League

**Winter Competition:** The winter netball competition run by FNA



## FREO FIRST POLICY

### Policy Objective

The policy has been designed to articulate the commitment to the FNA Futures program while also:

- closely aligning with the talent identification process with NWA Pathways
- ensuring a thorough and transparent selection process for athletes and coaches in the Sharks program is followed, and
- ensures the highest standard athletes and coaches are selected to provide the best opportunity for success in the WANL Competition.

It is the responsibility of all involved parties to ensure they conform to this policy.

### Freo First

We commit to selecting athletes and coaches from the FNA Futures programs in priority to those from outside by the program where possible

- 1) As part of the Athlete Selection Policy and Coach Selection Policy consideration is given to current and previous participation in the FNA Futures program.
- 2) Where there is an FNA Coach or Athlete available to fill a position and they have the appropriate skills and experience to fill the position, they will be considered above a similar non-FNA Coach or Athlete.
- 3) When a position becomes available we search for an appropriate candidate within the FNA community in the first instance, and only advertise outside our community if an appropriate candidate cannot be identified.
- 4) We have capacity for extended FNA Futures squads to allow for access to replacement athletes and training partners for Sharks.
- 5) We create opportunities for FNA Futures Coaches and Athletes to access the WANL environment through Sharks in safe and manageable ways.
- 6) If a non-FNA coach is appointed, a specific agreed plan will be included in their contract to ensure there is an appropriate connection to FNA to encourage the sharing of knowledge and skills with the FNA Futures pathway.
- 7) If a non-FNA Athlete is contracted, they will be required to participate in an agreed program with FNA or one of its Affiliated Clubs in a way that is mutually agreed with the Committee. Examples are included later in the policy.



## **FNA Athletes**

An FNA Athlete is defined as meeting at least one of the following criteria:

- 1) Is an active player or coach at an Affiliated Club
- 2) Is an active player or coach in an FNA Futures program
- 3) Is an active member of the FNA Umpiring Squad or Academy

## **Non-FNA Athletes**

A non-FNA Athlete is any Athlete not meeting the criteria for an FNA Athlete.

To comply with the objectives of the policy, if a non-FNA Athlete is contracted, they will be required to participate in an agreed program with FNA or one of its Affiliated Clubs. The agreed program should align to the skills and interests of the non-FNA Athlete.

Examples of the types of program that would be agreed include but are not limited to:

- 1) Registering as a player for the Winter season at an Affiliated Club
- 2) Registering as a coach for the Winter season at an Affiliated Club
- 3) Registering as a coach of the FNA NetSetGo program
- 4) Developing and running an inclusion program at FNA across the Winter season
- 5) In consultation with the ADO, developing a selection process, training program and coaching an FNA representative team to participate in a NWA carnival not already attended by FNA (such as NAIDOC, Multicultural Carnival etc)
- 6) Participating in the TID and Selection Program for FNA Representative team programs
- 7) Other not insubstantial involvement as suggested by the non-FNA Athlete and agreed by the Committee

If the agreed activity is not completed, the non-FNA Athlete will be considered to be in breach of the Sharks Participation Agreement.

## **Changes to Policy**

This Policy may be reviewed, cancelled, amended or supplemented by the Committee as and when it sees fit.



## ATHLETE SELECTION POLICY

### Policy Objective

Sharks selects and manages teams in the WANL Competition, comprising:

- Open Team
- 21 & Under Team
- Futures Team

The policy has been designed to select teams, as determined by the Committee, which:

- considers the Freo First Policy
- closely aligns with the talent identification process with NWA Athlete Pathway;
- ensures a thorough and transparent selection process is followed, and
- ensures the highest standard athletes are selected to provide the best opportunity for success in the WANL Competition.

It is the responsibility of all involved parties to ensure they conform to this policy.

### Process

An Athlete Selection Panel will be appointed to select players. The panel shall fully comply with this Policy when selecting each team.

The appointed Athlete Selection Panel will select the teams by majority voting. Should the Athlete Selection Panel be split equally on any athlete the Head Coach of the team being selected shall have the determining vote. However in making any selections, the Head Coach must comply with the provisions of this Policy.

Any member of the Athlete Selection Panel or any party involved in selection decisions will recuse themselves from selection decisions relating to their own family member.

The Open Team will comprise between 12 and 14 Contracted Athletes and may include Training Partners

The 21&U Team will comprise 12 Contracted Athletes

The Futures Team will comprise between 12 and 16 Athletes and may include Training Partners

The Committee has authority to amend the composition of the Athlete Selection Panel at their discretion, including the appointment of apprentice selectors.

The Committee has the authority to change the composition of any Team to comply with changes to the WANL Handbook.



## Athlete Eligibility

Athlete eligibility criteria for selection in Sharks Teams are listed below, and are subject to change as directed by NWA to comply with the current WANL Handbook.

All athletes must be drug free and compliant with Netball Australia's Anti-Doping Policy and Integrity Framework requirements and be a current affiliated member of NWA.

<b>Open Team</b>	<ul style="list-style-type: none"><li>• Minimum 16 years of age as of 31 December of the year of competition</li><li>• Training partners must not be eligible for the 21&amp;U Team</li></ul>
<b>21 &amp; Under Team</b>	<ul style="list-style-type: none"><li>• Minimum 16 and maximum 21 years as of age as of 31 December of the year of competition</li></ul>
<b>Futures Team</b>	<ul style="list-style-type: none"><li>• Minimum 15 and maximum 18 years of age, as of 31 December of the year of competition</li><li>• Must be eligible for the FNA "Representative Team Athlete Policy (2023)" in the year of competition</li></ul>

## Selection Procedure

Trials may not be held for positions in the Open Team. Athletes may express their interest, and will be selected based on the requirements of the team, Player Points, and the Selection Criteria.

For 21&U and Futures Teams, the process for selection will be determined by the Selection Panel based on the requirements of the team and the Selection Criteria. Trials may be held for Teams or certain positions in Teams at the discretion of the Athlete Selection Panel, and/or expressions of interest may be called for.

If required, trials will occur at dates, venues and times to be determined by the Athlete Selection Panel and the Committee. To be eligible for selection via trials, Athletes shall complete the nominated Trial Registration Form and pay the non-refundable trial fee, prior to the stipulated date.

If an athlete is unable to attend scheduled trials (i.e. injured or away) the Trial Registration Form must be completed and the Selection Panel notified before the Trial Registration period ends. The Athlete Selection Panel is not obligated to arrange for alternate means of viewing of any athlete. If it is decided to do so, alternate means of viewing (i.e. video footage) may be considered by the Athlete Selection Panel.

Offers to athletes will be made in accordance with NWA processes. Unsuccessful athletes will be advised of this decision. Successful athletes will be required to accept the offer and sign the NWA Participation Agreement and the Athlete Participation



Agreement by date stipulated, for their position at the club to be valid, and failure to comply may result in the offer being deemed void.

The Athlete Selection Panel and Committee shall be under no obligation to provide reasons for its selection decisions although it may elect to do so at its discretion.

The Sharks Participation Agreement will include information about athlete commitments, uniform requirements and fees.

### **Selection Criteria**

Selection may be based on but not limited to the following selection criteria:

- Skill level
- Ability to handle pressure on and off the court
- Attitude and behaviour
- Ability to learn from feedback and apply to game
- State of physical fitness, health and well being
- Past performances
- Current National Squad or AIS Member status
- Current or potential injury or condition which may impair, inhibit or prevent the participant's performance to the requisite level
- Potential for future elite teams
- Team composition and playing position
- Tactical knowledge and game awareness
- Attendance at required sessions for the selection process
- Financial with NWA and any other WANL club
- Current NWA affiliation
- The Freo First Policy
- Other factors considered by the Selection Panel to be important

Invitees may be invited to train with any team at the discretion of the Coaches and Athlete Selection Panel, with prior approval of the Committee.

### **Fees**

Fees will be based on the Sharks budget and set for each season and must be paid when due.

### **Changes to Policy**

This Policy may be reviewed, cancelled, amended or supplemented by the Committee as and when it sees fit.



## COACH SELECTION POLICY

### Policy Objective

Sharks selects and manages teams in the WANL Competition, comprising:

- Open Team
- 21 & Under Team
- Futures Team

The policy has been designed to appoint coaches, as determined by the Committee, which:

- considers the Freo First Policy
- closely aligns with the NWA Coaching Pathway;
- ensures a thorough and transparent process is followed, and
- ensures the best opportunity for success in the WANL Competition.

It is the responsibility of all involved parties to ensure they conform to this policy.

### Process

A Coach Selection Panel will be appointed to recommend coach and manager appointments to the Committee for ratification.

The Committee has authority to amend the composition of the Coach Selection Panel at their discretion.





## Coach Eligibility

Coach eligibility criteria for appointment to Sharks Teams are listed below, and are subject to change as directed by NWA to comply with the current WANL Handbook.

All Coaches and Managers must be a current registered member of NWA, hold a current Working with Children Check, and comply with the conditions of the GIG WANL Participation Agreement and NWA Integrity Framework.

## Selection Procedure

Applications for vacant Sharks Coach and Manager positions shall be called for at a date determined by the Committee if unable to be filled from the existing Coaches and Managers, coaches in the FNA Futures pathway, or at the discretion of the Committee.

Applications for vacant positions are to be submitted to Admin. All applications must detail Applicants qualifications, skills and experience as per the Coach Application Form. The applicants are to be shortlisted by the Coach Selection Panel in line with the selection criteria. Interviews may be held with shortlisted candidates if required.

Applicants will be advised of the outcome of the selection process by the Committee.

The Coach Selection Panel and Committee shall be under no obligation to provide reasons for its selection decisions to applicants although it may elect to do so at its discretion.

## CODE OF CONDUCT

### Process

A breach of the Code of Conduct will be managed by the Committee.

### The Code

Sharks' values are Integrity, Community and Excellence. All Sharks apply these values when we are representing Sharks or FNA. This includes Contracted Athletes, Training Partners, Coaches, Team Managers, Committee and any other person in the Sharks environment.

- 1) Respect the rights, dignity and worth of fellow players, coaches, officials and spectators
- 2) Refrain from conduct which could be regarded as sexual or other harassment
- 3) Respect the talent, potential and development of fellow players and competitors
- 4) Care and respect the equipment and resources provided to you
- 5) Be frank and honest concerning illness and injury and your ability to fully participate at training and games
- 6) Conduct yourself in a responsible manner relating to language, temper and punctuality
- 7) Operate within the rules and spirit of netball, promoting fair play over winning at any cost
- 8) Maintain a high standard of personal behaviour at all times
- 9) Respect the decisions of umpires, officials, coaches and administrators in the conduct of the sport
- 10) Act with integrity and objectivity and accept responsibility for your decisions and actions
- 11) Adopt appropriate and responsible behaviour in all interactions

- 2) The Committee fails to exercise its duties as per this agreement or Sharks policy,
- 3) The season is cancelled due to any Force Majeure Events, or
- 4) Sharks, as per its licence agreement held by FNA, ceases operations.



## SUFFICIENT FUNDS

The payment of any amount under this agreement is subject to Sharks having sufficient money available for the payment of honorariums.

The Committee may in its absolute discretion, determine whether it has sufficient money available for payment under this agreement, either in whole or in part. If it is determined there are not sufficient funds to make any honorarium payment under this agreement, the Committee may terminate this agreement without affecting your obligations under this agreement in relation to any part of the honorarium already paid.

The Committee are not liable to you in any way if this agreement is terminated under this clause and you are unable to make any claim against Sharks, FNA or the Committee for any loss suffered as a result of termination of this agreement.

## DISPUTES

Any dispute concerning this agreement shall be subject to arbitration in accordance with the policies of Sharks as listed on the website and amended from time to time.

## ATHLETE PARTICIPATION AGREEMENT

### SHARKS MISSION STATEMENT

We will provide a positive environment that engages, nurtures, and challenges the best players, coaches, umpires, and officials in the Fremantle community. With a vision to represent Sharks as the leader of the WANL competition, while offering a pathway for those aspiring individuals, through to the high performance pathway of Netball WA.

### PLAYER MISSION STATEMENT

To represent Sharks and my team to the best of my ability and ensure that the ideals of netball - participation, fitness, competition, teamwork and, above all, sportsmanship - are always maintained.

### PLAYER COMMITMENTS

It is expected that all Sharks players meet the following commitments:

- Registration of personal details in PlayHQ when requested.
- Payment of all playing and training fees, including any additional uniform expenses when requested.
- Attendance at each game, scheduled training and pre-season, unless prior arrangements are made with the Head Coach.
- Attendance at all Club events including the Club Day, Camp day, Season Launch, and Awards Night as applicable.
- Completion of personal fitness/gym sessions as instructed by the Coach.
- Active participation in Sharks fundraising and community events. The specific events and dates will be detailed in the Calendar of Events.
- Completion of a minimum of 5 hours of community engagement.
- Active participation in all Sharks media commitments, including but not limited to interviews, press conferences, promotional events, and social media interactions.
- Attendance at any organised training games, including promotional, sponsorship and developmental activities.
- Submission to the Head Coach, a medical certificate from a qualified Medical Practitioner or clearance from a Physiotherapist which clears you to recommence training or playing after an injury or serious illness.
- Notification in writing the reasons for any leave of absence request, through the Head Coach, at least four weeks before any leave of absence that is required from games, training or fitness sessions.
- Respond to communications from Sharks within the designated timeframe.
- Compliance with the requirements of the Athlete Participation Agreement and all relevant policies of Netball WA and Sharks.



## CALENDAR OF EVENTS AND FEES

The Calendar of Events and GIG WANL Fixtures will be provided when available.

Fees for the season have not yet been finalised by Netball WA or Sharks. These will be provided when available.

## CODE OF CONDUCT

You are representing Sharks at all times whilst involved in all activities listed in Player Commitments. We expect our players to adhere to all Sharks and Netball WA policies (as listed on the websites and amended from time to time). Whilst we expect all players enjoy their experience at Sharks, it is also important that we do so whilst respecting those around us.

Failure to maintain the Code of Conduct will lead to disciplinary action, which may include the player being withdrawn from their team.

The Code of Conduct also applies to Sharks supporters, and we expect our Supporters including Guardians/Spouses to adhere to. Any deviations from the Code of Conduct will not be accepted.

<b>Most Valuable Player (MVP)</b>	<ul style="list-style-type: none"><li>• Selected from the contracted athletes on each team.</li><li>• Determined by a 3, 2, 1 voting system, with 3 being for the best performance, with voting by the coaches of the team after each Round, and collated at the end of the regular season.</li><li>• Awarded to the athlete who ranks most highly in the voting system based on playing performance throughout the WANL season.</li></ul>
<b>Runner-up MVP</b>	<ul style="list-style-type: none"><li>• Selected from the contracted athletes on each team.</li><li>• Determined by the MVP voting system.</li><li>• Awarded to the athlete who ranks second in the voting system based on playing performance throughout the WANL season.</li></ul>
<b>Coaches Award</b>	<ul style="list-style-type: none"><li>• Selected from the contracted athletes in each team.</li><li>• Determined by the team coaches.</li><li>• Awarded to an athlete who demonstrates excellent sportsmanship, leadership, or team qualities, on or off the court, during the WANL season.</li></ul>
Sharks Awards	
<b>Shark of the Year</b>	<ul style="list-style-type: none"><li>• Selected from all contracted athletes, coaches, team managers, and other direct participants in Sharks during the WANL season.</li><li>• Determined by the Committee.</li><li>• Awarded to an individual who consistently represents Sharks positively and passionately, and who demonstrates excellent values and behaviours.</li></ul>
<b>Volunteer of the Year</b>	<ul style="list-style-type: none"><li>• Selected from all volunteers for Sharks.</li><li>• Determined by the Committee.</li><li>• Awarded to an individual who gives a significant contribution to the club through their volunteering efforts through the WANL season, and demonstrates an outstanding commitment to the club.</li></ul>



## Process

The Committee will confirm the Team Award recipients with the coaches after selection based on the criteria.

The Committee will select the Sharks Award recipients based on the criteria.

There will be one of each Sharks Award annually, unless otherwise determined by the Committee.

There will be one of each Team Award for each team (e.g. an MVP for the Open, 21&U, and Futures teams). Where athletes are on an equal numbers of points, there may be additional awards made up to a total of four awards per team.

The Committee has authority to amend the criteria of the awards in this policy at their discretion.
